The Tidewater Soil and Water Conservation District is a political subdivision of the Commonwealth of Virginia serving the counties of Gloucester, Mathews, and Middlesex. The District is empowered to develop comprehensive programs and plans that conserve and improve the quality of soil and water resources. The leadership of the District is committed to two basic concepts; local citizens can best identify and find solutions to local environmental and conservation issues and the District, or through assistance with its cooperating agencies, will assist individuals with their natural resources conservation planning and problem solving. The District is governed by an eight-member board of directors who serve a four-year term. Six directors, two from each county, are elected in a general election. Two directors are appointed by the Virginia Soil and Water Conservation Board, one of these appointees must be a Virginia Cooperative Extension Agent. Non-voting associate directors may be selected by the Tidewater SWCD Board of Directors. The daily operations of the District are conducted by the staff which consists of a District Manager, Conservation/Education Specialist, and Conservation Office Assistant. Technical assistance is provided by the Commonwealth of Virginia Department of Conservation and Recreation and the USDA Natural Resources Conservation Service. The District maintains a close working relationship with the Virginia Association of Soil and Water Conservation Districts, Virginia Cooperative Extension, Virginia Department of Forestry, USDA Natural Resources Conservation Service and Farm Service Agency, and other federal, state, and local agencies. Operating funds are provided by grants and appropriations from state and local governments. The Commonwealth of Virginia supports the Tidewater Soil and Water Conservation District through financial and administrative assistance provided by the Virginia Soil and Water Conservation Board and the Department of Conservation and Recreation. All programs, services, and employment opportunities of the Tidewater Soil and Water Conservation District are offered on a nondiscriminatory basis, without regard to race, color, national origin, religion, sex, age, marital status, handicap, or political affiliation.

EDUCATION




"Where would we BEE without pollinators?"

Virginia Agricultural Cost Share Best Management Practices (BMP) Program

Tidewater SWCD Board of Directors conducted business meetings with local partners:

Directors and employees attended the virtual annual meeting of the Virginia Association of Soil & Water Conservation Districts. The meeting included training sessions, business meetings, partner agency updates, and guest speakers.



The Area III Spring Meeting was held virtually on April 20th, 2021 both directors and employees were in attendance. Our District Manager, LaVerne Calhoun, took the minutes of the meeting which consisted of partner agency updates, a business meeting, and guest speaker, Ms. Barbara Hamm Lee. As president/CEO of Sharing Info, LLC, producer and host of "Another View" radio show, and as a DEIJ Consultant/Facilitator, Ms. Hamm Lee delivered a motivational and interactive session on diversity, equality, and inclusion. She also facilitated a Q&A session providing anonymity for the participants, to provide more specific implementation practices and guidance for justice.

Staff from Clifton Larson Allen LLP (CLA), under contract with the Department of Conservation and Recreation (DCR), completed a virtual audit for Tidewater Soil and Water Conservation District for fiscal years 2019 and 2020. Tidewater SWCD was commended for their sound fiscal management of public funds.

Mr. Benton also practices no-till farming to help prevent runoff and to maintain soil health. He also has many of his acres under a Resource Management Plan, guaranteeing his land will be maintained with conservation in mind for years to come. For the last 12 years, he has participated in our Cover Crop Cost Share program. Jason understands the importance of maintaining vegetative cover on cropland through the winter, when food crops are not typically grown. Cover crops hold the soil in place with their roots and improve soil health by adding additional organic matter.

Despite the global COVID-19 pandemic the Tidewater Soil & Water Conservation District remained resilient, positively impacting state and national conservation efforts in a socially responsible manner.

Employees attended virtual trainings provided by the Association of Virginia Soil & Water Conservation Districts and the Department of Conservation & Recreation on topics such as erosion fundamentals, personnel management, and the Virginia Agricultural Cost Share Program among various other administrative and technical trainings.

NATURAL RESOURCE MANAGEMENT

The Tidewater Soil and Water Conservation District administers the Virginia Agriculture Cost Share Best Management Practices Program which offers Cost Share assistance as an incentive to install or implement voluntary BMPs. BMPs improve water quality in the state's streams, rivers, and Chesapeake Bay.
