College Scholarships Available Applications Due March 20th

The Tidewater Soil and Water Conservation District, through the Virginia Association of Soil and Water Conservation Districts, has TWO scholarship opportunities available. These scholarships are intended to promote the education of Virginia citizens in technical fields of natural resource conservation and environmental protection. The awards will be considered for students majoring in, or showing a strong desire to major in, a course curriculum related to natural resource conservation and/or environmental studies. All applicants must be residents of Gloucester, Mathews, or Middlesex County.

One scholarship, in the amount of \$1,000.00, was established in memory of Mathews County resident, Mr. Martin J. Menges, a former District Director. Mr. Menges was co-founder and past president of the York River Chapter of the Chesapeake Bay Foundation, and co-founder of the watershed group Save the Ole Piankatank. Tidewater Soil & Water Conservation District will select the winner for the Martin J. Menges scholarship.

The Virginia Association of Soil and Water Conservation Districts will award four freshmen level scholarships in the amount of \$1,000.00 each on a statewide competitive basis. Each SWCD is to select one freshman applicant and forward the application to the VASWCD office for consideration. Applicants need to complete only one application which will be used for both the VASWCD and Martin J. Menges scholarships.

All submitted paperwork is confidential and becomes the property of the VASWCDEF.

2022 Clean Water Farm Award Winner Carlton & Calhoun Farms, Inc.

Roger Calhoun of Carlton & Calhoun Farms, Inc. has been farming for 41 years. Upon graduating from high school in 1981, Roger and his brother, Steven, struck up a partnership with their "Papa", William H. Carlton. Their operation consisted of raising hogs, cattle, grain crops, hay and logging operations.

Around 1997, due to economic reasons, the decision was made to no longer raise livestock. In 2007, Roger became sole owner of the farming operation, which was incorporated as Carlton & Calhoun Farms, Inc.

Roger attributes becoming a farmer to his "Papa," William H. Carlton, who can be credited for Roger's desire and passion for farming. The Carlton portion of the business name "Carlton & Calhoun Farms, Inc." is in honor of William H. Carlton. Roger feels blessed he had Mr. Carlton's teaching, training, and being able to witness his Papa's compassion for being a farmer.

Roger inherited that compassion and work ethic to pass it on by teaching his son and grandsons the benefit of utilizing Best Management Practices. He has all of his acres in Tidewater District signed up for continuous no-till.

Roger split applies his nitrogen on corn and small grains to minimize runoff to our waterways. He maintains grass buffers around his fields to minimize nutrient and soil loss. Roger also utilizes crop rotation practices and cover crops .

Roger currently has the privilege of farming alongside his son, Dustin Calhoun. Dustin has worked fulltime for Carlton & Calhoun Farms, Inc. since graduating from college. The farm has one other fulltime employee, Peachie Brown, Jr., who has been employed by the farm for over 35 years. Roger looks forward to the day when he passes his legacy, Carlton & Calhoun Farms, Inc, on to Dustin and his two sons. Tidewater Soil and Water Conservation District is proud to honor the values passed down from William H. Carlton by awarding Roger Calhoun of Carlton & Calhoun Farms, Inc. the 2022 Tidewater Clean Water Farm Award.

Youth Conservation Camp Deadline April 25, 2023

Youth Conservation Camp applications are now available at the Tidewater Soil and Water Conservation District for Gloucester, Mathews, and Middlesex students that are in the 9th -12th grade during the 2022-2023 school year. Youth Conservation Camp is a week long camp that is sponsored by the VA Association of Soil and Water Conservation Districts for a week of learning about Virginia's natural resources from conservation professionals and faculty from Virginia Tech. Most of the instruction is hands-on and outdoors. Two students are chosen by Tidewater SWCD to attend this camp at Virginia Tech each year. Camp admission, meals and lodging during the camp (a \$550.00 value) are provided by Tidewater SWCD. Transportation to and from camp is the sole responsibility of the camper. While at camp, students will bunk in the college dorms and be involved in many activities and educational events. 2023 Cost Share Updates

March 15, 2023: Nutrient Management Plans Due to District Office

Producers are required to have an up-to-date nutrient management plan on file in order to receive cost share payments. This is a busy time of year for plan writers, please do not wait to contact them.

March 15th - June 1, 2023: Cover Crop Kill-down and Reporting Period

All cover crops must be terminated after March 15th but before June 1, 2023 to qualify to receive cost share payment. Producers who signed up for the late kill-down incentive payment must wait until May 1, 2023 to begin kill-down in-order to receive the additional \$10/acre incentive.
